Sample Problems for Drafting

- 1. Mr. Akash Mitra purchased a high-end smartphone from Y Mobiles, located at Burdwan Road, Siliguri. After two weeks of use, the phone started overheating and frequently shutting down. Despite multiple requests for repair or replacement, Y Mobiles neither repaired the phone nor provided a replacement. Akash Mehra suffered financial loss and inconvenience due to the malfunctioning phone. Additionally, Y Mobiles did not honor the one-year warranty provided at the time of purchase. Draft a consumer complaint on behalf of Akash Mehra to be filed with the District Consumer Disputes Redressal Forum, alleging breach of warranty, negligence, and seeking appropriate compensation.
- 2. Ms. Meera Nair recently purchased a flat from XYZ Developers in Sunshine Towers, located in Andheri, Mumbai, in 2020. Shortly after moving into the flat, Ms. Nair discovered significant issues with the plumbing system. The water pressure in the bathrooms was inconsistent, and the kitchen sink would frequently clog, causing water to back up and create an unhygienic environment. Despite making several complaints to XYZ Developers, the company sent unskilled workers who temporarily fixed the issue. However, after two months, the plumbing problems resurfaced, leading to a severe leakage that damaged the walls and flooring. The maintenance of the building block is still under the responsibility of XYZ Developers for the next two years. However, no further action has been taken by the developers to address the persistent plumbing issues, leaving Ms. Nair frustrated and facing additional repair costs. Draft a consumer complaint on behalf of Ms. Meera Nair to be filed with the District Consumer Disputes Redressal Forum, seeking permanent repairs of the plumbing system, compensation for the damages caused to the flat, and damages for the inconvenience and distress suffered due to the developer's negligence.
- **3.** Ms. Rhea Kapoor, a resident of Banjara Hills, Hyderabad, purchased a home theater system during the Big Discount Bonanza Sale from eShopify, an online marketplace. The system was a new model released by SonicBoom Electronics, a brand exclusively sold through eShopify. Upon setting up the home theater system, Ms. Kapoor discovered that the

subwoofer was not functioning properly, resulting in poor sound quality. She immediately contacted eShopify's customer service to report the issue and request a replacement or refund. However, the customer service team kept delaying the process, asking for repeated verifications, and eventually stopped responding to her queries. It has been over a month since Ms. Kapoor first raised the complaint, and eShopify has not provided any resolution, causing her significant frustration, financial loss, and inconvenience. Draft a consumer complaint on behalf of Rhea Kapoor to be filed with the District Consumer Disputes Redressal Forum, seeking a replacement or refund for the defective home theater system, as well as compensation for the mental agony and inconvenience caused by eShopify's negligent handling of the issue.

- **4.** Suman Shah, a resident of Uttorayon, Siliguri, subscribed to a high-speed internet plan from ABC Internet Services on 1st August 2024, paying an advance amount of Rs. 10,000 for six months. However, she faced frequent disruptions and slow speeds, which affected her ability to work from home. Despite repeated complaints, ABC Internet Services failed to resolve the issue. Suman now wants to approach the District Consumer Forum to seek redressal. Draft a consumer complaint for Suman, detailing the deficiency in service and requesting a refund of the advance payment along with compensation for the inconvenience and loss of work.
- **5.** Aman Sharma, bought a washing machine from HomeEssentials, a shop located in Bidhan Market, Siliguri on 10th July 2024 for Rs. 20,000. The washing machine worked fine for the first month but later started making loud noises and eventually stopped working. Aman contacted HomeEssentials, but they refused to repair or replace the washing machine, stating that the warranty had been voided due to "misuse." Aman insists that he used the washing machine as per the instructions and wants to file a complaint. Draft a consumer complaint for Aman against HomeEssentials, demanding the repair or replacement of the washing machine and compensation for the mental stress caused by their refusal to honor the warranty.

- **6.** Priya Kumar, ordered a custom-made sofa from FurnitureWorld, Kamla Nagar, New Delhi, on 1st May 2024, paying Rs. 15,000 as an advance. The delivery was promised within 30 days. However, even after three months, the sofa was not delivered, and FurnitureWorld kept delaying the delivery date without providing a valid reason. Priya now wishes to file a complaint in the District Consumer Forum to get her advance payment back along with compensation for the delay. Draft a consumer complaint for Priya against FurnitureWorld, seeking a refund of the advance payment, compensation for the delay, and an order to expedite the delivery of the sofa if Priya still wants it.
- 7. Shreya Yadav, purchased a premium home theater system from SoundScape Electronics, New Market, Kolkata, on 10th March 2024, after being influenced by an advertisement that promised "immersive surround sound and crystal-clear audio quality." The system cost her Rs. 80,000. Upon installation, Shreya noticed that the sound quality was subpar, with frequent distortions and poor bass output. The system also lacked some features that were prominently advertised, such as wireless connectivity. Shreya contacted SoundScape Electronics multiple times to either rectify the issues or provide a refund, but they claimed that the product was functioning as intended and refused any assistance. Shreya feels that the product was misrepresented through false advertising and is defective. Draft a consumer complaint for Shreya, citing the misrepresentation and defects in the home theater system, and seek a full refund, compensation for the misleading advertising, and damages for mental harassment.
- 8. Rahul, a credit card holder with SecureBank, discovered an unauthorized debit of Rs. 50,000 from his account on 25th June 2024. Rahul immediately reported the issue to the bank's customer service, who assured him that the matter would be resolved within 7 working days. Despite following up several times, the bank failed to reverse the transaction or provide any satisfactory explanation. Rahul's attempts to escalate the issue within the bank were met with indifference, and he was advised to wait longer without any definite timeline. The prolonged delay has caused Rahul financial distress and anxiety, as the money was urgently needed for his sister's medical treatment. Draft a consumer complaint for Rahul against SecureBank, demanding an immediate reversal of the unauthorized debit, compensation for the financial loss, and damages for the mental agony caused by the bank's negligence and poor customer service.

9. On 1st April 2024, Anil Kumar, pre-ordered the latest XYZ gaming console from TechWorld, Bandra West, Mumbai, paying Rs. 30,000 as a pre-booking amount. The console was supposed to be delivered by 1st May 2024, as per the agreement. However, the delivery date passed without any updates from TechWorld. Anil repeatedly contacted the store, but each time he was either given vague responses or asked to wait longer. By 1st August 2024, Anil had still not received his console. Meanwhile, the price of the console had decreased, and it was available in other stores at a lower price. Anil feels cheated by TechWorld, who has neither delivered the product nor refunded his money. Draft a consumer complaint for Anil against TechWorld, seeking a refund of the pre-booking amount, compensation for the delay and mental harassment, and an order directing TechWorld to deliver the console immediately or pay the price difference.

10. Meera Naik was admitted to CityCare Hospital, Rajajinagar, Bangalore, on 15th May 2024 for a minor surgical procedure. She was assured by the hospital staff that the surgery would be straightforward and that she would be discharged within two days. However, due to the negligence of the attending surgeon, the surgery led to complications, requiring Meera to stay in the hospital for an additional two weeks. During this period, Meera was subjected to multiple unnecessary tests and was billed an exorbitant amount of Rs. 2,50,000, which was far beyond the initial estimate of Rs. 50,000. Despite repeated requests, the hospital refused to provide an itemized bill or address the complications arising from the surgery. Meera believes that the hospital was negligent in its duty of care and engaged in unfair billing practices. Draft a consumer complaint for Meera against CityCare Hospital, seeking compensation for the additional medical expenses, damages for the negligence and physical suffering caused, and an order for the hospital to provide an itemized bill and refund any unjustified charges.

Despite making several complaints to XYZ Developers, the company sent unskilled workers who temporarily fixed the issue. However, after two months, the plumbing problems resurfaced, leading to a severe leakage that damaged the walls and flooring. The maintenance of the building block is still under the responsibility of XYZ Developers for the next two years. However, no further action has been taken by the developers to address the persistent plumbing issues, leaving Ms. Nair frustrated and facing additional repair costs. Draft a consumer complaint on behalf of Ms. Meera Nair to be filed with the District Consumer Disputes Redressal Forum, seeking permanent repairs of the plumbing system, compensation for the damages caused to the flat, and damages for the inconvenience and distress suffered due to the developer's negligence.
- **3.** Ms. Rhea Kapoor, a resident of Banjara Hills, Hyderabad, purchased a home theater system during the Big Discount Bonanza Sale from eShopify, an online marketplace. The system was a new model released by SonicBoom Electronics, a brand exclusively sold through eShopify.

Upon setting up the home theater system, Ms. Kapoor discovered that the subwoofer was not functioning properly, resulting in poor sound quality. She immediately contacted eShopify's customer service to report the issue and request a replacement or refund. However, the customer service team kept delaying the process, asking for repeated verifications, and eventually stopped responding to her queries. It has been over a month since Ms. Kapoor first raised the complaint, and eShopify has not provided any resolution, causing her significant frustration, financial loss, and inconvenience. Draft a consumer complaint on behalf of Rhea Kapoor to be filed with the District Consumer Disputes Redressal Forum, seeking a replacement or refund for the defective home theater system, as well as compensation for the mental agony and inconvenience caused by eShopify's negligent handling of the issue.

- **4.** Suman Shah, a resident of Uttorayon, Siliguri, subscribed to a high-speed internet plan from ABC Internet Services on 1st August 2024, paying an advance amount of Rs. 10,000 for six months. However, she faced frequent disruptions and slow speeds, which affected her ability to work from home. Despite repeated complaints, ABC Internet Services failed to resolve the issue. Suman now wants to approach the District Consumer Forum to seek redressal. Draft a consumer complaint for Suman, detailing the deficiency in service and requesting a refund of the advance payment along with compensation for the inconvenience and loss of work.
- 5. Aman Sharma, bought a washing machine from HomeEssentials, a shop located in Bidhan Market, Siliguri on 10th July 2024 for Rs. 20,000.
